**EXPERIENCED Vacuum Truck & Hydro Excavator Driver/Operator
With Class A or B CDL

Position Description:

A driver/operator will drive and operate vacuum trucks and hydro excavator trucks as well as other duties as needed. This position requires the following:

- Must have Class A or B Commercial License with X Endorsement (HazMat & Tanker).
- Must be able to speak, read and write English.
- Must be able to travel – position includes a minimum of 50% travel.
- Must have at least one (1) year previous vacuum truck and hydro excavator driving and operating experience.
- Must live within 45 minutes of the Garner office location that you are applying at.

Responsibilities:

A driver/operator is responsible for the operation and care of the piece of equipment that they are assigned to use. Sufficient knowledge of the equipment to complete an effective checklist before start-up, to determine any defects or safety problems that could be associated with the machinery, and efficient operation of the equipment is needed. Operator must assure that protective equipment such as guards, seatbelts, horns and back-up alarms, windshields, etc. are in good condition.

Physical requirements:

Some of the physical requirements of this position will include but are not limited to the below and may require the use of personal protective equipment such as chemical resistant suits, gloves, boots, and respiratory equipment.

- Removing contaminated sorbent from a contaminated area
- Loading and unloading cargo, equipment and materials as directed
- Jobs duties may be performed on land or on water
- Lifting, pushing, pulling, moving, carrying up to 50 pounds without assistance
- Sitting and standing for long periods of time
- Bending, stooping, squatting, climb ladders and stairs
- Sweep, shovel, mop, rake, dig and utilize various types of hand tools
- Open and close valves of various sizes
- Operate various types of winches and cable pulleys
- Perform job duties at various heights & must have a good sense of balance – cannot be afraid of heights
- Perform job duties in all types of weather conditions
- Perform rescue duties on victims if needed

Employment Standards:

Each operator shall be trained and qualified on the specific piece of equipment to be operated. All required licenses, DOT requirements, certifications, and equipment check-offs are required to operate specific equipment. Each trained equipment operator shall have on their person, while operating a piece of equipment, a qualifying card indicating the type and/or size of equipment to be operated. All employees are required to follow rules, regulations and guidelines as provided through Employee Handbook, Health and Safety Manual, completion of application process and plant entry requirements, day-to-day directions and instructions as outlined by supervisors and/or management.

Education/Experience:

On the job, as well as operator's courses provided by employer, state licensing, DOT requirements, and outside certifications and assessments (i.e. NCCER) are required. All operators of equipment shall be verified by the Company Competent Person, (defined as a qualified operator of the equipment being verified).

Knowledge of:

The workings and limitations of the equipment they are operating. How to deal with local and federal agencies, such as DOT, DPS, Fire Depts., R/R commission, health dept., etc. Employee shall demonstrate competency of probing for line location, as well as notification of effected pipeline and utility companies in the area. Must know, understand and utilize when applicable, the "One Call" system.

Skill at:

Working with heavy equipment, must operate with full knowledge and awareness of surroundings at all times, including overhead and other equipment working the same area (roll off trucks, vac. trucks, hydro excavator, etc.)
